- iii) <u>Place To:</u> enter name of the place where goods are being transported To.
- iv) <u>State:</u> Select sate of the place where goods are being transported To.
- v) Mode of Transport: Select Rail or Road or Air.
- vi) <u>Vehicle Number Known:</u> if you know vehicle number select **Yes** and enter vehicle No, Vehicle owner name, Vehicle owner Address else select **No** and enter Transporter name and Transporter Address.
- vii) <u>Nature of Transaction:</u> select nature of transaction.

Supplier / Recipient Details

- i) <u>GSTIN:</u> enter gstin number of the party.
- ii) Legal Name: enter legal name of the party.
- iii) <u>Trade Name:</u> *enter trade name of the party*.
- *iv)* <u>Principle Place of Business:</u> *enter principle place of business of the party.*
- v) <u>Tax office: enter tax office of the party (optional).</u>

Incase of Inter State:

- h. <u>IGST(%):</u> select from the given values.
- i. <u>IGST Value:</u> enter IGST value.

j. <u>CESS:</u> *enter cess.*

- k. <u>Value(Rs.):</u> enter value.
- I. <u>Document No: enter document number</u>.
- *m.* <u>Document Date:</u> *enter document date.*
- n. <u>HSN CODE:</u> enter hsn code(optional for any commodity except others).
- o. <u>Commodity:</u> select from given values.
- p. <u>Other commodity:</u> *enter other commodity if you have selected "other" for Commodity column.*
- q. <u>Quantity:</u> enter quantity.
- r. <u>UOM(Units of Measerment):</u> select from the given values.

- 13) Click on "**choose file**" button and locate your excel template then click on "**Upload File**" button.
