In the ref. 1<sup>st</sup> & 4<sup>th</sup> cited, Government has rationalized/reorganized the Commercial Taxes Department, Telangana with 118 circles for better monitoring of Tax Payers and Revenue Generation in view of increase in registrations. However, the Jurisdictions of the circles and allocation of taxpayers to respective jurisdictions have not been notified subsequent to the reorganization done vide 4<sup>th</sup> cited.

In accordance to the G.O.Ms. No. 103, (18) new circles have been created and in exercise of the powers vested under Sub-section (2) of Section 4 of TGST Act, 2017, Jurisdictions are hereby assigned to all 118 circles under 14 divisions along with allocation of taxpayers to respective jurisdictions based on the Geographical locations w.e.f. 01.07.2024.

The list consisting of Jurisdictions of Circles & Divisions and details of taxpayers allocated to jurisdictions is appended to this Notification the tax Payers list will be made available under the "GST Circulars" tab on TGCT Portal.
