ORDER:

1. In the reference 3rd cited, a provisional seniority list in the cadre of Senior Assistants of Zone-I as per Presidential Orders 2018 was issued.
2. In the references 4th & 5th cited, certain individuals have filed objections and the objections are examined as per the report of the JC(ST), Warangal Division vide reference 6th cited and available records & rules. The details are as follows:

Sri N.Kiran Kumar, Sr. Asst.,

The individual has submitted that his name is recorded as "Nayini Kiran Kumar Reddy" in the provisional seniority list instead of "Kiran Kumar Nayini" and requested to change the same.

Reply:

The request of the individual has been examined and the Service Register has been verified. It is found that his correct name is "Kiran Kumar Nayini." Accordingly, the request of the individual is considered.

Sri M. Raja Narender Reddy, Sr. Asst.,

The individual has submitted an objection regarding the placement of Sri Bashipaka Kumara Swamy at Sl. No. 20 in the provisional seniority list. He has contended that the said individual was relocated from Basara (Zone II) to Kaleshwaram (Zone I) as per Presidential Orders with reference to G.O. Ms. No. 317, dated 06-12-2021 (through appeal). He has further stated that, as

per the applicable rules, an employee who has changed zones should be assigned zero seniority and placed below all existing employees in the new zone but he was placed above him.

Reply:

The cadre strength of Senior Assistants in Zone-I is 24, and accordingly, 24 candidates were allotted to Zone-I at the time of zonal bifurcation under G.O. Ms. No. 317. Subsequently on appeal, Sri Bashipaka Kumara Swamy was shifted from Zone-II to Zone-I. Sri B. Kumara Swamy is senior as per the seniority list of Senior Assistants of Zone-V earlier to Presidential Order 2018 to Sri M. Raja Narendra Reddy. Hence, Sri B. Kumara Swamy was placed at Sl.No. 20. His reallotment proceedings does not specify the condition to forego seniority. The appeal filed by Sri B. Kumara Swamy was heard and disposed on merits as per the provisions of G.O 317 and his shifting from Zone-II to Zone-I did not arise from any relaxation of rules.

Therefore, the objection of the individual cannot be considered and rejected.

3. In view of the above, the proposed provisional seniority list of Senior Assistants of Zone-I is hereby finalised and placed at Annexure.

4. The appeals if any, against this seniority list, should be filed within (90) days before appellate forums from date of publication of this seniority list in the portal of C.T. Department.

5. The above seniority list will be subject to the outcome of SLP/W.Ps/ O.As/ appeals pending if any, before the various Courts/Appellate Forums/ Government etc.
