ORDER:

1. In the reference 3rd cited, a provisional seniority list in the cadre of Senior Assistants of Zone-II as per Presidential Orders'2018 was issued.
2. In the reference 4th and 5th cited, certain individuals have filed objections and the objections are examined as per the report of the JC(ST) Warangal Division vide reference 6th cited and available records & rules. The details are as follows:

1. Sri. A. Sanjeev Kumar, Sr. Asst., (Sl. No. 30):

Sri A. Sanjeev Kumar, Senior Assistant, O/o Joint Commissioner (ST), Nizamabad Division, has submitted a representation regarding the provisional seniority list of Senior Assistants of Zone-II. The individual has stated that he was initially appointed as Junior Assistant through APPSC Group-IV (Notification No. 40/2008) on 02-11-2011 and was promoted as Senior Assistant on 26-03-2021. He has submitted that individuals placed at Serial Nos. 23 to 37 were also promoted on 26-03-2021; however, his name is placed at Serial No. 30, which appears inconsistent. He further stated that, if seniority is considered based on age, only one individual is senior to him and the others are juniors.

2. Sri. D. Praveen, Sr. Asst., (Sl. No. 34):

Sri D. Praveen, Sr. Asst, O/o the Joint Commissioner (ST), Nizamabad Division, has submitted a representation regarding the provisional seniority list of Senior Assistants of Zone-II. The individual has stated that he was initially

appointed as Junior Assistant through APPSC Group-IV (Notification No. 40/2008) on 02-11-2011 and was promoted as Senior Assistant on 26-03-2021. He has submitted that individuals placed at Serial Nos. 23 to 37 were also promoted on 26-03-2021. However, his name is placed at Serial No. 34, which appears inconsistent. He further stated that, if seniority is considered based on age, only four individuals (S Ashok, A. Sanjeev Kumar, P. Sharada and M. Suchitra) are senior to him and the others are juniors. The individual requested to re-consider his placement in the seniority list.

Replies:

The above individuals were allotted to Zone II from erstwhile Zone VI and they were promoted as Senior Assistants on 26-03-2021.

The individuals at Sl.Nos. 23 to 37 of Provisional Seniority List of Senior Assistants of Zone-II were promoted as Senior Assistant on 26-03-2021 in erstwhile Zone-V and VI. Therefore, the date of appointment in lower cadre i.e., Junior Assistant is taken for fixing up of Seniority in the cadre of Senior Assistants in Zone-II under the provisions of Rule 33 (a) of Telangana State & Subordinate Service Rules, 1996 as follows:
