Reply:

It is to inform that that no promotions have been effected after the issuance of the said G.O.Ms. No. 99, GA (Ser.D) Department, dtd. 14-04-2025. As per its provisions, the existing/old seniority list shall not be revised, and the guidelines prescribed therein shall be followed prospectively for future promotions. The said G.O. will be implemented henceforth. Therefore, the request of the individual for change of seniority based on G.O.Ms. No. 99, GA (Ser.D) Department, dtd. 14-04-2025 cannot be considered and is rejected.

3. In view of the above, the proposed provisional seniority list of Senior Assistants of Zone-III shown at Annexure is hereby confirmed.
