ORDER:

1. In the reference 3rd cited, a provisional seniority list in the cadre of Senior Assistants of Zone-IV as per Presidential Orders 2018 was issued.
2. In the reference 4th to 13th cited, certain individuals have filed objections and the objections are examined as per the report of the JC(ST) Warangal Division vide reference 14th cited and available records & rules. The details are as follows:

Sri. Ch. Srinivas Reddy, Sr. Asst., (Sl. No. 6):

The individual has submitted that, in the provisional seniority list, his date of appointment in the cadre of Senior Assistant has been recorded as 01-01-2015 instead of the actual date, i.e., 31-12-2014.

Reply:

On verification of the relevant records, it is found that his date of appointment in the said cadre is 31-12-2014. Accordingly, the request of the individual is considered. Necessary corrections are made in the seniority list.

Sri. JVNJ. Srinivas, Sr. Asst.,(Sl. No. 11)

The individual has submitted that, in the provisional seniority list, his date of appointment in the cadre of Senior Assistant has been recorded as 02-01-2018 instead of the actual date, i.e. 31-12-2014.

Reply:

On verification of the Service register, it is found that his date of appointment is wrongly recorded in provisional seniority list and his date of appointment in Sr.Asst cadre is 31-12-2014. Accordingly, the request of the individual is considered and necessary corrections are made in the seniority list.

Sri. M. Vamsheedhar, Sr. Asst., (Sl. No. 12):

The individual has submitted that, in the provisional seniority list, his date of appointment in the cadre of Senior Assistant has been recorded as 16-03-2002 instead of the actual date, i.e., 31-12-2014.

Reply:

On verification of the relevant records, it is found that his date of appointment in the said cadre is 31-12-2014. Accordingly, the request of the individual is considered and necessary corrections are made in the seniority list.

Smt. S. Mamatha, Sr. Asst.,(Sl. No. 14):

The individual has submitted that she was initially appointed as Typist under Special Recruitment Drive for Persons with Disabilities (PH–VH) during the year 2002 and was subsequently promoted as Senior Assistant on 31-12-2014. She has further stated that in the provisional seniority list of Senior Assistants of Zone-IV, her name is shown at Serial No. 14; however, the PH (VH) category has not been indicated against her name, unlike in respect of other individuals at Sl. Nos. 39, 48, and 50.

Reply:

On verification of the relevant records, it is confirmed that she belongs to PHC (VH) category. Accordingly, the request of the individual is considered, and it is assigned PHC (VH) category against her name at Sl. No. 14 in the seniority list.

Sri. P. Ravi Kiran, Sr. Asst.,(Sl. No. 16):

The individual has submitted that Sri Ch. Srinivas Reddy (Sl. No. 6) was shown with a date of appointment as Senior Assistant as 01-01-2015 and Sri Jillapalli Venkata Naga Jaya Srinivas (Sl. No. 11) as 02-01-2018 in the provisional seniority list. He has stated that he was promoted as Senior Assistant and reported to duty on 31-12-2014 and, since his date of appointment is earlier than that of the above individuals, he is senior to them as per the applicable rules governing seniority. He has therefore requested correction of his position in the seniority list.

Reply:

On verification of the relevant records, it is found that the dates of appointment of the said individuals were erroneously recorded as 01-01-2015 and 02-01-2018 in the provisional seniority list. The correct date of appointment in respect of both individuals is 31-12-2014. In view of the above, the objection of the individual is rejected. Necessary corrections are made in the seniority list.

Sri. P. Yadagiri, Sr. Asst.,(Sl.No. 26)

The individual has submitted that Smt Banoth Rambai (Sl. No. 18) was shown with a date of appointment as Senior Assistant as 02-01-2015 in the provisional seniority list. He has stated that he was promoted as Senior Assistant on 31-12-2014 and, since his date of appointment is earlier than that of the above individual, he is senior to her as per the applicable rules governing seniority. He has therefore requested correction of his position in the seniority list.

Reply:

On verification of the relevant records, it is found that the dates of appointment of the said individual was erroneously recorded as 02-01-2015 in the provisional seniority list. The correct date of appointment in respect of Smt Banoth

Rambai (Sl. No. 18) is 31-12-2014. In view of the above, the objection of the individual is rejected. Necessary corrections are made in the seniority list.

Smt. N. Radhika, Sr. Asst., (Sl. No. 29):

The individual has submitted that her name is placed at Sl. No. 29 in the provisional seniority list without mention of her special category (PHC–OH).

Reply:

A notice to submit the latest SADAREM certificate on 24-09-2024, the individual had not submitted the SADAREM certificate at the relevant time. The individual has now submitted her UDID certificate on 17-03-2026. The same was recorded in her Service register. Therefore, her special category (PHC–OH) is now incorporated against her name in the seniority list.

Smt. K. Kalyani, Sr. Asst., (Sl. No. 43):

The individual has submitted that, in the provisional seniority list, her date of birth has been recorded as 15-04-1980 instead of the actual date, i.e., 15-04-1985.

Reply:

On verification of the Service register, it is found that her date of birth is correctly 15-04-1985. Accordingly, the request of the individual is accepted, and necessary corrections are made in the seniority list.

Sri. M. Jagadiswar, Sr. Asst., (Sl. No. 55)

The individual has stated that he was appointed as Jr. Assistant on 02-05-2013, whereas, Sri Perumallapalli Sreekanth (Sl. No. 54) was appointed on 12-02-2014 and requested to consider his seniority above him.

Reply:

Upon verification of the roster register of Senior Assistants of erstwhile Zone V, it is observed that Sri M. Jagadiswar was placed at Serial No. 19 against Roster Point No. 90 (OC), and Sri P. Srikanth was placed at Serial No. 26 against Roster Point No. 97 (SC). In view of the above, the objection raised by the individual has been examined and considered. Sri M. Jagadiswar (Serial No. 19) is senior to Sri P. Sreekanth (Sl. No. 26) at feeder category i.e., Junior Assistant cadre. Accordingly, the individual's name is placed at Serial No. 54, and Sri P. Sreekanth name is placed at Serial No. 55 because of roster point.

Smt. S. Sathyavathi, Sr. Asst.,(Sl. No. 69)

The individual has submitted that her seniority in the cadre of Senior Assistant may be fixed by taking into account her date of appointment, regularization, and declaration of probation in the feeder category of Junior Assistant.

Reply:

As per the rules governing seniority, the seniority in the cadre of Senior Assistant is determined based on the date of promotion to the said cadre and not with reference to the service rendered in the feeder category. Further, a punishment of stoppage of two annual grade increments without cumulative effect on 5-12-2019. After completion of punishment, her name was considered for promotion on 31-12-2024 and her seniority has been fixed accordingly in the provisional seniority list. Therefore, the request of the individual is therefore rejected.

3. In view of the above, the proposed provisional seniority list of Senior Assistants of Zone-IV is hereby finalised as placed at Annexure.

4. The appeals if any, against this seniority list, should be filed within (90) days before appellate forums from date of publication of this seniority list in the portal of C.T. Department.

5. The above seniority list will be subject to the outcome of SLP/W.Ps/ O.As/ appeals pending if any, before the various Courts/Appellate Forums/ Government etc.
