ORDER:

1. In the reference 3rd cited, a provisional seniority list in the cadre of Senior Assistants of Zone-V as per Presidential Orders 2018 was issued.
2. In the reference 4th to 10th cited, certain individuals have filed objections and the objections are examined as per the reports of the JC(ST) Hyderabad Rural Division and Nalgonda Division vide references 14th and 15th cited and available records & rules. The details are as follows:

The above individuals filed common objections stating that the individuals i.e., Smt R. Yashaswini (Sl. No. 14), Smt Pingali Jamuna (Sl. No. 15), Sri Masood Husen (Sl. No. 16) and Smt D. Vidyavathi (Sl. No. 17) are juniors to them in the cadre of Junior Assistant. They were promoted as Sr. Assistants on 26-03-2021. The above individuals have requested to rectify the provisional seniority list by placing their names the above (4) individuals by taking their date of appointment in the cadre of Junior Assistants.

Reply:

The following Senior Assistants — (1) Smt. Maddi Sarala, (2) Sri Manohar Chitgopikar, (3) Sri. Bhavani Ashok, (4) Sri Mohd. Zeeshan Shakeel, (5) Sri Madhu, (6) Sri Janipasha, (7) Sri Syed Saleem, (8) Sri Syed Khan, and (9) Sri Abdul Muneem—have raised objections stating that, during the implementation of the Presidential Orders, the officials Smt. R. Yashaswini, Smt. Pingili Jamuna, Sri Maqsood Husen, and Smt. D. Vidyavathi were transferred from the erstwhile Zone-V (comprising Adilabad, Karimnagar, Warangal, and Khammam Districts) to the present Zone-V (comprising Suryapet, Nalgonda, Yadadri Bhuvanagiri, and Jangaon Districts). It is contended that the names of these officials were placed above those of the existing Zone-V Senior Assistants, despite their date of appointment in feeder category i.e., Junior Assistants being later to them and simultaneous promotion to the cadre of Senior Assistant.

The objections submitted by the concerned Senior Assistants have been examined in detail. When the date of promotion in the cadre of Senior Assistant is same i.e., 26-03-2021 then the date of appointment in the feeder category i.e., Junior Assistant cadre is taken into consideration Based on this verification, the placements of the individuals are placed at appropriate places as under the provisions of Rule 33 (a) of Telangana State & Subordinate Service Rules, 1996 detailed below:

4. The appeals if any, against this seniority list, should be filed within (90) days before appellate forums from date of publication of this seniority list in the portal of C.T. Department.

5. The above seniority list will be subject to the outcome of SLP/W.Ps/ O.As/ appeals pending if any, before the various Courts/Appellate Forums/ Government etc.
