ORDER:

1. In the reference 3rd cited, a provisional seniority list in the cadre of Senior Assistants of Zone-VI as per Presidential Orders 2018 was issued.

2. In the references 4th to 14 & 16th cited, certain individuals have filed objections and the objections are examined as per the report of the JC(ST), Secunderabad Division vide reference 15th and 18th cited and available records & rules. The details are as follows:

1. Smt. Seema Sehgal, Sr. Asst., (Sl. No.88):

The individual has stated that her date of promotion is erroneously mentioned as 18-05-2016 instead of 12-05-2016 and requested to necessary corrections.

Reply:

After verifying the promotion order copy submitted by senior Assistant Smt.Seema Sehgal, vide proceedings of the Deputy Commissioner(CT), Secunderabad Division Proceedings No: A2/103/2011 Dt: 12-05-2016, it is noticed that her promotion date is 18-05-2016 erroneously mentioned instead of 12-05-2016. Hence, the same is hereby corrected in the final Seniority list of Senior Assistants of Zone-VI. Hence objection is considered.

2. Smt. Pathloth Akhila, Sr. Asst.,(Sl. No. 230):

The individual has stated that her date of birth is mentioned as 15-04-1976 instead of 26-12-1996 and her date of Joining as Senior Assistant is mentioned as 01-01-2025 instead of 31-12-2024 and requested to rectify the same in the seniority list.

Reply:

After verifying with the Service Register of the individual, it is found that her date of Birth is 26-12-1996 and her date of Joining as Senior Assistant is 31-12-2024. Hence, the same is hereby rectified in the final Seniority list of Senior Assistants of Zone-VI. Hence, objection is considered.

The above individuals have stated that Senior Assistant, Sri Aleemuddin Mohammed, who is placed at Sl.No. 71 in the Provisional Seniority list of Senior Assistants of Zone-VI should be placed at Sl.No. 91 as his date of promotion as Senior Assistant is 03-11-2016, after Kaveti Indira (Sl.No.90) as Senior Assistants from Sl.No 72 to 90 are promoted as Senior Assistants on 12-05-2016 which is earlier to promotion of Sri.Aleemuddin Mohammed and requested to rectify the same.

Sri. M. Sateesh, Senior Assistant, O/o Joint Commissioner(ST), Punjagutta Division has also requested to mention his date of appointment as 28-08-2017 instead of 30-08-2017.

Reply:

As verified from the Promotion Proceedings of the above Senior Assistants vide proceedings of the Deputy Commissioner(CT), Secunderabad Nodal Division Proceedings No. A2/103/2011 Dt: 12-05-2016, and the Promotion proceeding of Sri Aleemuddin Mohammed, Senior Assistant vide proceedings of the Deputy Commissioner (CT), Hyderabad Rural Division Proceedings No: E2/140/20113 Dt: 02-11-2016 and the Service Register copies of Sri Mohammed Aleemuddin, it is evident that Sri Aleemuddin Mohammed, Senior Assistant, presently working in the O/o Assistant Commissioner(ST), Fathenagar Circle, Hyderabad Rural Division is Junior to Sl.No: 72 Sri Naveen Kumar Pothu to Sl.No. 90 Smt Kaveti Indira. Hence it is found that he has been erroneously placed at Sl.No.71 instead of Sl.No. 90 after Smt Kaveti Indira. Hence, Sri Mohammed Aleemuddin is placed at Sl.No.90 below Smt Kaveti Indira in the Seniority list of Senior Assistants of Zone-VI.

Further, as per the Service Register of Sri. M. Sateesh, the promotion date of Sri. M. Sateesh as Senior Assistant is 28-08-2017. Hence, the same is hereby rectified and also for all the Senior Assistants from Sl.No.97 to 103. Hence, objections are considered.

9. Sri Talatam Mohan Sai Kiran, Senior Assistant, O/o Assistant Commissioner(ST), Jubilee Hills-I Circle, Punjagutta Division, (Sl.No: 226):

11. Sri Kuchan Venkata Krishna, Senior Assistant, O/o Assistant Commissioner(ST), Jubilee Hills-I Circle, Punjagutta Division, (Sl.No: 260):
12.(17) Senior Assistants from Punjagutta Division objection Dated: 20-03-2026.

The individuals have stated that their date of appointment as Senior Assistant is mentioned as 01-01-2025 instead of 31-12-2024 and requested to consider the same.

Reply:

After verifying with the copy of Promotion order of the individuals issued vide TG CCT's Proceeding No. C/E/1017/Z-VI/2024 Dt: 31-12-2024, and from verifying from the Service Registers of the individuals, the promotion date of the Senior Assistants is 31-12-2024. Hence, the same is hereby changed in the Seniority list of Senior Assistants of Zone-VI. Hence objections are considered.(During verification it is noticed that for Senior Assistant from Sl.No. 218 to Sl.No. 354 the date of appointment as Senior Assistant was erroneously mentioned as 01-01-2025 instead of 31-12-2024 in provisional seniority list. Hence, the same are rectified in the final list.).

13.Sri P. Shiva Sagar, Senior Assistant, O/o Assistant Commissioner(ST), Keesara-2 Circle, Malkajgiri Division, (Sl.No: 242):

The above individual has stated that his date of promotion is wrongly mentioned as 30-08-2025 and his actual date of promotion is 31-12-2024 and requested to rectify the same.

Reply:

As per the Service Register of the individual, the date of promotion of the individual is 31-12-2024. Hence, the objection is considered.

14.Smt A. Sunitha, Senior Assistant, O/o AC(ST), Madhapur-II Circle, Madhapur Division, (Sl. No. 105):

The above individual has stated that her date of appointment is wrongly mentioned as 06-06-2018 instead of 01-06-2018 and requested to restore her actual date of appointment as 01-06-2018.

Reply:

As per the Service Register of the individual, the date of promotion of the individual is 01-06-2018. Hence, the objection is considered.

3. In view of the above, the proposed provisional seniority list of Senior Assistants of Zone-VI is hereby finalised as placed at Annexure.

4. The appeals if any, against this seniority list, should be filed within (90) days before appellate forums from date of publication of this seniority list in the portal of C.T. Department.

5. The above seniority list will be subject to the outcome of SLP/W.Ps/ O.As/ appeals pending if any, before the various Courts/Appellate Forums/ Government etc.
