SHOW CAUSE NOTICE

TG CCT's Ref.No. D2/962/2019

Sub: Public Services – Commercial Taxes Department - Preparation of Seniority list in the cadre of Commercial Tax Officer from the period from 2013-14 (from 2nd June 2014) to 2017-18 – Show Cause Notice – Issued – Objections invited from the affected persons – Regarding.

1. In the reference 1st cited, the seniority list in the cadre of Commercial Tax Officers for the period from 1975-76 to 2013-14 upto 1st June'2014 was finalized by both the Commissioners of Commercial Taxes of Andhra Pradesh and State of Telangana, as the period is covered to both States. The said seniority list was published in Telangana Gazette Part-II Extraordinary Gazette vide reference 2nd cited.

2. After bifurcation of the State, as per availability of vacancies, ad-hoc/ temporary promotions / appointment by transfers were issued as Commercial Tax Officers from the eligible / qualified Deputy Commercial Tax Officers/ Superintendent Grade-I (Gazetted) / Section Officers & PS to Secretaries to Government in the State.

3. Now, it is decided to prepare the subsequent seniority list of Commercial Tax Officers for the periods from 2013-14 (from 2nd June'2014) to 2017-18 basing on the availability of vacancies in each panel year by following the Service Rules and other rules governed to the post of Commercial Tax Officer. While preparing the proposed seniority list of CTOs of above period, the following principles were followed.

- I. The Telangana Commercial Taxes Service Rules, 1994 issued by Government vide G.O.Ms.No.360, Revenue (CT-I) Dept., dtd:23-04-1994 and subsequent amendments along with latest amendment issued by the Government vide G.O.Ms.No.85 Revenue (CT.I) Department, dtd:27-05-2017.
- II. The post of Commercial Tax Officer is a State cadre post upto 30.08.2018 (in view of New Presidential Orders' 2018, it became multi zonal post from 31.08.2018).
- III. As per the present Service Rules, the cadre strength of Commercial Tax Officers shall be filled in the following manner.
 - i) 33 1/3% - By Direct Recruitment
 - ii) 53 2/3% - By Promotion
 - iii) 10% - By transfer from Section Officers and Private Secretaries to Secretaries to Government
 - iv) 3% - By transfer from Superintendent Grade-I (Gazetted) working in the O/o the Commissioner of Commercial Taxes

- IV. The proposed seniority of Rank Promotees is prepared based on the feeder category integrated seniority list of DCTOs.
 - V. The Government of Telangana vide its Circular Memo No. 1450-A/Ser.D/A1/2014-4, General Administration (Ser.D) Department, dtd. 27-05-2015 has issued instructions for commencement of fresh roster in State of Telangana for State cadre posts (in State of Telangana from 02.06.2014).
 - VI. The Government have also forwarded the final cadre strength of C.T. Department (issued by Government of India letter dtd. 28-01-2016) vide Memo No. 2556/Rev/CT.I/2016, dtd. 17-02-2016.
 - IX. The Telangana State and Subordinate Service Rules, 1996, have also taken in the matter along with Rule of Reservations.
 - X. Due care has been taken while placing the Handicapped persons as per orders of the Government vide G.O.Ms.No.203, Revenue (CT-I) Dept., dated 10.03.2010 read with G.O.Ms.No. 360, Revenue (CT.I) Dept., dtd.23-04-1994 and G.O.Ms.No.42, Department for Women, Children, Disabled & Senior Citizens (DW), dated 19-10-2011.
 - XI. The word panel year is mentioned for the purpose of calculation of vacancies and not mentioned for notional promotions / seniority etc., Further, it is noted that the expression 'panel year' is used herein only for the purpose of convenience, and not with any other intention.
4. The proposed seniority list of CTOs for the panel years from 2013-14 (from 2nd June, 2014) to 2017-18 is prepared and appended as Annexure to this show Cause Notice.
 5. The list of persons as shown in the Annexure appended to this notice may file their written objections, if any, to this notice within 15 days from the date of issue of this notice in the official web-site of the Department i.e. www.tgct.gov.in, lest it will be construed that they have no objections to this notice and orders as deemed fit under law would be passed without any further notice in this regard.
 6. The above Show Cause Notice shall be subject to the outcome of SLP/W.Ps/O.As / appeals pending if any, before the various Courts / Appellate Forums / Government / Competent Authorities etc.,
