



#### **STUs & CIRCLES**

 Each division has 1/2/3 number of Strategic Tax Payer Units (STUs), Each STU has 60 Top taxpayers covering taxable persons making supply of goods and services

 STUs are headed by Deputy Commissioners of State Taxes

### **STUs & CIRCLES**

- The entire jurisdiction of the division is divided into circles
- Each circle has around 2000 to 250 dealers
- Circle is headed by Assistant Commissioners
- They are assisted by State Tax Officers(1/2), Deputy State Tax Officers (3/4) and Staff.

# OIC (Official In charge)

#### **OIC Functions:**

Apart from their regular entrusted duties the Deputy State Tax Officers also have to function as OIC in collection of Returns and Tax balances under GST and other Acts as allotted from time to time.
